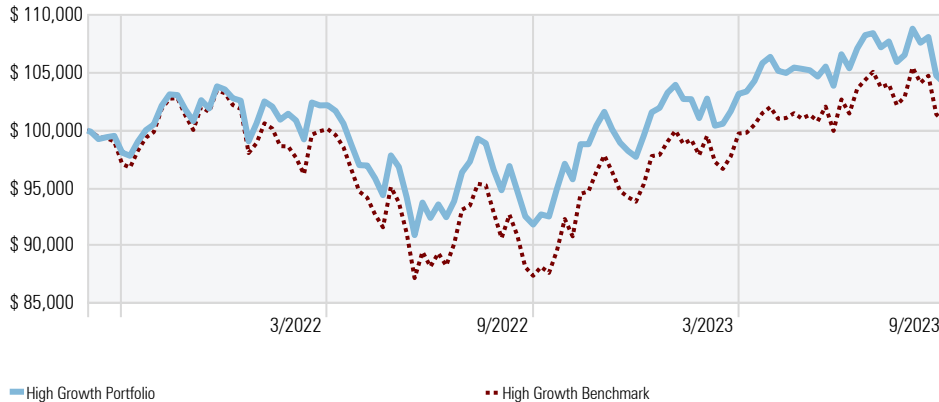

The portfolio may deliver returns comparable to those of the broader equity market with similar levels of risk and volatility.

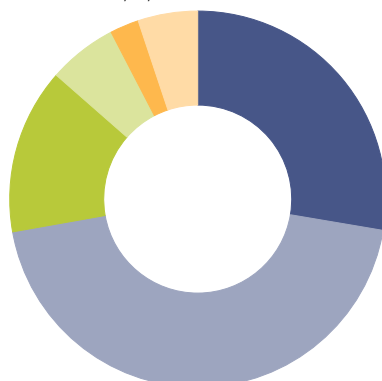
